<b><i>Circulation by AIMA investment manager members</i></b>	
An employee of an AIMA investment manager member provides it to another employee of that investment manager member firm for its internal use	Permitted use
AIMA investment manager member fills in DDQ and provides it to an investor or platform provider that is also an AIMA member	Permitted use
AIMA investment manager member fills in DDQ and provides it to an investor or platform provider that is not an AIMA member	Permitted use
<b><i>Circulation by investors that are AIMA members</i></b>	
An investor that is an AIMA member (an 'Authorised Investor') provides the blank DDQ to an AIMA investment manager member to complete	Permitted use
An Authorised Investor provides the blank DDQ to an investment manager that is <u>not</u> an AIMA investment manager member to complete	Permitted use
<b><i>Circulation by platform providers that are AIMA members</i></b>	
A platform provider that is an AIMA member (an 'Authorised Platform Provider') provides the blank DDQ to an AIMA investment manager member to complete	Permitted use
A platform provider that is an AIMA member provides the blank DDQ to an investment manager that is <u>not</u> an AIMA member to complete	Permitted use
<b><i>Use by investment managers that are not AIMA members</i></b>	
An investment manager that is not an AIMA member obtains the blank DDQ from an Authorised Investor or Authorised Platform Provider and fills it in and provides it only to requesting Authorised Investor or Authorised Platform Provider, as applicable	Permitted use
An investment manager that is not an AIMA member obtains the blank DDQ (whether or not from an Authorised Investor or Authorised Platform Provider) and fills it in and provides it to anyone other than an Authorised Investor or Authorised Platform Provider	<b>Not permitted</b>
<b><i>Circulation by service providers that are AIMA members</i></b>	
An employee of an AIMA service provider member provides it to another employee in the same office of that service provider member firm for its internal use	Permitted use

Action	Permitted Use/Not Permitted
An employee of an AIMA service provider member provides it to another employee in a different office of that service provider member firm for its internal use	<b><i>Permitted use if the receiving employee is in an office of the service provider that is itself an AIMA member; otherwise not permitted</i></b>
An AIMA service provider member makes the blank DDQ available to a client that is an AIMA member	Permitted Use
An AIMA service provider member makes the blank DDQ available to a client that is <u>not</u> an AIMA member	<b>Not permitted</b>
<b><i>Transformation to electronic platform form for onward circulation</i></b>	
An AIMA member transforms the blank DDQ into an electronic platform format or other format to make available to its own clients that are AIMA members	<b><i>Permitted use only under the terms of a written licensing agreement with AIMA</i></b>
An AIMA member transforms the blank DDQ into an electronic platform format or other format to make available to its own clients that are <u>not</u> AIMA members	<b>Not permitted</b>
A non-AIMA member transforms the blank DDQ into an electronic platform format or other format to make available to its own clients that are AIMA members	<b><i>Permitted use only under the terms of a written licensing agreement with AIMA</i></b>
A non-AIMA member transforms the blank DDQ into an electronic platform format or other format to make available to its own clients that are <u>not</u> AIMA members	<b>Not permitted</b>
<b><i>All other circulations and uses</i></b>	
Any person provides a blank or completed DDQ to anyone except in the permitted use circumstances set out above	<b>Not permitted</b>
