

SCOTIABANK ALTERNATIVE MUTUAL FUND INDEX

The Scotiabank Alternative Mutual Fund Index ended May 2023 **down -0.66%** MOM on an asset-weighted basis and **down -1.14%** MOM on an equal-weighted basis.

Our index tracks the monthly equal-weighted performance of constituents classified as Canadian Alternative Mutual Funds, as defined by National Instrument 81-102. Given the emerging nature of liquid alternatives, there is no minimum track record, or AUM, required for inclusion in the Index at this time. We are now tracking the performance of 74 funds, split between equity and credit-focused strategies and are adding new constituents as the market grows. Given the growth of new funds and participants in the Canadian Alternative Mutual Fund market, we draw your attention to the fact that we have added 13 new funds to our index this month.
