AIMA Canada (Alternative Investment Management Association) is proud to announce the launch of its annual national university case competition to help university students in Canada learn about the alternative investment industry.

Presented by the Community Engagement Committee, the AIMA Canada Alternative Investment University Case Competition is an inter-university portfolio design competition, offered to create awareness of alternative investment management functions and careers while facilitating students' learning and networking opportunities in the field.

The challenge will see students work in teams to present solutions for a case study that will focus on incorporating certain alternative investment strategies and asset classes into a traditional institutional investment portfolio. The primary objective of the competition is to expose students to the benefits, challenges, and risks of incorporating alternative investments into investment portfolios. The secondary objective is to gain familiarity with an area of financial services that is rapidly growing in importance and size.

Education is especially critical for our upcoming graduates. AIMA Canada is excited to help the next generation of driven and insightful young professionals learn about our industry's opportunities, mechanics, and benefits for becoming a globally minded investor.

ELIGIBILITY REQUIREMENTS

If you meet these requirements, then most likely you are eligible to apply!

- Preference: Enrolled in a Master of Finance or MBA program within a Canadian University
- All students must be a current or recently-graduated graduate-level student. This includes MBA, PhD, MD (up to but not including residency), JD, and Masters candidates.

Your team must meet all the eligibility requirements to be selected to compete.

- *Team composition:* The teams competing must include a minimum of 3 students to a maximum of 5 students. Teams may be comprised of students from different schools in Canada only.
- Dual degree programs, such as a 5-year program that results in a graduate degree, are allowed. "Current" means currently seeking a degree, enrolled on a full- or part-time basis (i.e., in the academic year from July 1, 2021 through June 30, 2022).
 "Recently graduated" means students who will graduate any time after September 1, 2021. (For example, December 2021 graduates are eligible to compete).

Not eligible: Undergraduate university students

HOW TO APPLY

One member of your team, the designated leader, should complete the simple online application by:

 Multiple student teams from the same school, institution or university in Canada may apply to compete. There is no limit on the number of applications per school.
- There are no fees to apply or to compete. Once an application is submitted, no changes can be made.
