Eligibility

- AIMA Investor Xchange – London is an invitation-only networking event for senior representatives of eligible asset managers and institutional investor firms.
- Priority will be given to AIMA members.
- Participation is limited to one delegate per organisation initially. AIMA may increase spaces per firm if places are available much closer to the event
- Submission of an application does not guarantee a place at the event.

- Applications will be reviewed to ensure a balanced mix of investors and asset managers, taking into account factors such as seniority, organisation type, investment strategy, and the objectives of the event.
