

CHAIRMAN'S MESSAGE



The year that was 2015 established another record-breaking period for AIMA Canada. Membership in AIMA Canada increased to 135 while maintaining our traditional proportion of 60% managers, and 40% investors and service providers.

With the help of our many volunteers, we were able to organize a total of 60 events (educational, networking and social) throughout 2015. Educational events included 10 Career Panel events held across Canada, our biennial New & Emerging Managers Series, the content of which is available in written and video form for members on our website, as well as traditional events such as our Annual Debate and Montréal Grand Prix Panel and Regulatory Updates. Over 3,000 attendees to these events shows the interest in and impact of these informative and interactive forums. Our social gatherings, including ski days, golf

days, summer socials and wine and cheese receptions continued to represent just under 40% of AIMA Canada's overall programming, consistent with the previous five years. A complete list of all 2015 AIMA Canada events can be found on pages 4 to 7.

We provided opportunities for Canadian managers to promote their funds to investors both within Canada (through matchmaking sessions available at the inaugural AIMA Canada Hedge Fund Conference) and on a global basis through the continuation of our Canadian Embassy/Consulate Reception Series which saw managers participate in events held in Chicago, Tokyo, Hong Kong and Singapore in 2015.

Each of AIMA Canada's nine Committees put on an average of two events for members during 2015 and our Legal & Finance Committee submitted six comment letters to securities regulatory authorities on topics of importance to the industry. Towards the end of 2015 we established the AIMA Canada Operations and Compliance Committee which will be focusing on and promoting best practices in these increasingly important and vital areas. I would like to take this opportunity to thank all of the Co-Chairs and committee members for volunteering their valuable time and for all of their hard work over this past year.

Our executive board includes Paul Patterson (Next Edge Capital), Claude Perron (Crystalline Management), Claire Van Wyk (RBC Global Asset Management), Derek Hatoum (PricewaterhouseCoopers LLP) and Tim Baron (Davies, Ward, Phillips and Vineberg LLP) as well as James Burron from AIMA Canada staff. Each providing complementary perspectives and skill-sets which should serve the organization well throughout 2016. Joining James as staff members in 2015 were Caroline Chow (full-time) and co-op students Matthew Chan and Patrick Lin (both from the University of Waterloo).

Looking to the year ahead on the regulatory front we expect that the CSA will be publishing a draft National Instrument which would permit alternative funds to offer their strategies for investment at the retail level in Canada. AIMA Canada has established a working group consisting of a broad cross-section of managers (both in terms of size and strategy) as well as critical service providers (administrators, prime brokerage, custodians, audit, and legal) and will be at the centre of these discussions helping to shape the framework of this National Instrument. Member input in this process will also be sought and will be essential in helping to ensure that the framework for this new offering regime is representative of our Industry.

We will also continue our work promoting Canadian managers to investors both within Canada and on a global basis. Nationally, we will be looking to increase our profile through public events and through the media. At the international level, this will be accomplished both through promotional efforts within AIMA and through a continuation of Canadian Embassy/Consulate events providing managers with the opportunity to network with foreign institutional investors.

I am very excited for the coming year and would like to take this opportunity to wish each of you and your families a Happy New Year! Together we can make 2016 the most meaningful and productive year for the Canadian alternative investment industry yet!

INDUSTRY REGULATORY AND ADVOCACY ACTIVITIES

AIMA Canada submitted a number of comment letters to the Canadian regulators on a variety of issues of interest to members and the industry at large.

Our various committees and working groups, and AIMA Canada and AIMA head office staff also had numerous meetings with various regulators across Canada on a variety of issues including the comment letter topics listed below.

AIMA Canada Comment Letter re: OSC Staff Notice 33-743 Regarding the Allocation of Expenses to Investment Funds (January 2015)

AIMA Canada opined, outside of a proposal for comment, that the recent OSC guidance to registrants regarding the allocation of certain costs to the fund versus being borne by the fund manager is too prescriptive and reduces investor choice in regard to allocations, potentially reduces transparency for investors, and is inconsistent with international trends and other published OSC guidance.

AIMA Canada Comment Letter regarding the potential of broadening the application of the Agreement on Internal Trade (AIT) (June 2015)

We supported the reduction of inter-provincial trade barriers (as many members have investors in other provinces and related frustration with coordinating with divergent views amongst Canadian regulatory bodies) and expressed concern over a disturbing trend toward decreased harmonization in certain key areas of registration, investor definition and regulation.

AIMA Canada Comment Letter regarding the Regulation on Financial Planning (August 2015)

AIMA Canada opined the definition of "financial planning" as put forward under the proposed legislation was over-extended and would lead to unnecessary requirements of registrants that would increase regulatory burden without commensurate amelioration of investor service or protection.

AIMA Comment Letter regarding the proposed amendments to 13-101 (SEDAR) and 13-102 (August 2015)

We noted that the fee to put Offering Memorandum (OM) into the public domain would not be offset by a reduction in administrative costs. As well, many have proprietary information in their OMs, intended only for investors and interested parties, and requiring this to be known to all may force registrants to discontinue this form of offering.

AIMA Canada Comment Letter regarding Anti Money Laundering (September 2015)

AIMA Canada supported the object of the Act and suggested ways to reduce duplication of effort, a reduction in the lookback (from 20 years to 5-10 years), and clarification on broad language used in the proposal.

AIMA Canada Comment Letter on the Proposed Amendments to National Instrument 45-106 Prospectus Exemptions relating to Reports of Exempt Distribution (October 2015)

We offered suggestions to Form 45-105F1 such as: consistency of categories used with regard to hedge fund strategies, reporting of fund NAV, recognition of base currencies of fund shares, and the requirement of an "end date" of a fund (which, for many hedge funds since they are open-ended and in continuous distribution, is not applicable).



COMMITTEE NEWS

Operations & Compliance replaces Manager Only

Members' interest continued to focus on operational and compliance issues while the 2014-formed Manager Only Committee had challenges in the establishment of regular meetings and topics. Thus, the Operations & Compliance Committee, consisting of manager and service provider members' personnel, was created to address these areas of interest and organize events, meet with regulators, and draft comment letters for the benefit of members and, as applicable, the industry at large.

AIMA CANADA ON THE ROAD, GLOBALLY

Working with the Department of Foreign Affairs, Trade and Development, AIMA Canada members have participated in twelve receptions (at our Embassy, High Commission, or Consulate General facilities, where possible) aimed to bring together Canadian hedge fund industry participants and global allocators and investors. Typically 8-12 funds meet with 15-40 qualified investors in a business networking setting which has led to allocations to the funds; side-meetings on topics of interest to members were also organized. 2016 events are planned in the United States, Europe, and Australia.



AIMA CANADA EVENTS

In 2015 AIMA Canada organized a record 60 events, 23 of which were socials (e.g., wine and cheese, ski, golf). Growth over the years has been significant (2010: 12; 2011: 13; 2012: 23; 2013: 32; 2014: 38) and due to the tremendous efforts of our committees (both in number and geographically) and growth in membership and our overall community. SEPTEMBER 4 – Vancouver Summer Social Moved from a rained-out August date, this social included a Vancouver Canadians baseball game, proving a big hit.



AIMA CANADA HEDGE FUND CONFERENCE

OCTOBER 7-8, 2015
St. Andrew's Conference Centre & The Hockey Hall of Fame
Toronto, Ontario

The inaugural AIMA Canada Hedge Fund Conference lived up to its goal with an excellent array of prestigious speakers and a 1:1:1 ratio among investor, manager and service provider attendees numbering 187 in total.

Spanning 1.5 days, it began with an investor-only hedge fund investing workshop featuring a noted academic and consultant, major institutional allocator, and alternatives expert, trader and consultant - followed by a general welcome reception.

The main day of the conference featured investor/allocator-only panels on trending topics such as due diligence, accessing hedge fund strategies, seeding and emerging managers, and perspectives on how to use hedge funds and hedge fund strategies in a portfolio setting.

The conference was under Chatham House Rule, where participants are free to use the information received, but neither the identity nor the affiliation of the speaker(s), nor that of any other participant, may be revealed. This allowed panelists to speak more freely and provided very insightful views for the audience.

Interspersed during the day were so-called speed-dating or match-making sessions where investors, managers, and service providers set aside time to meet and discuss offerings and requirements. These meetings were entirely opt-in for both sides and accommodated those who wished to have meetings as well as learn from the various panel discussions.

The second-day reception was held at the Hockey Hall of Fame with special speaker, and NHL hall of famer, Darryl Sittler speaking on what it takes to be a star - and how to keep grounded no matter the circumstances.

Speakers and attendees, all of which were either AIMA members or real money investors (e.g., pension funds, sovereign wealth funds, foundations, endowments, or single family offices), came from across Canada, the United States, the United Kingdom, Europe, Asia, and the Middle East.

Attendees and participants of all types gave high marks for the panels and many aspects of the conference as well as welcomed advice on how to make our next iteration even better.
