Dear AIMA Canada Members:

The year 2016 was another impressive one for AIMA Canada: total membership increased to 143 (8 net new members) and our events tally was a very busy 53 for the year – highlighted by the second edition of the AIMA Canada Investor Forum which brought close to 200 delegates to Montréal (it will return to that city in 2017 on September 25-26).

Educational events organized by AIMA Canada's various volunteer committees included nine career panel events held across Canada, "Adding Alternatives to Your Portfolio" (Ottawa, Edmonton) as well as traditional events such as our Annual Debate (a lively discussion of whether liquid alternative funds are the future of the industry), and Regulatory Updates. The approximate 3,000 cumulative number of attendees at these events shows the level of interest and impact of these informative and interactive forums. Our social gatherings, including ski days, golf days, summer socials, and wine and cheese receptions continued to represent just

under 40% of AIMA Canada's overall programming, consistent with the previous six years.

AIMA Canada provided opportunities for manager members to promote their funds to investors both within Canada (through matchmaking sessions at the Fall Investor Forum) and on a global basis through the continuation of our Canadian High Commission/Consulate Reception Series which saw managers participate in events held in London (preceded by an OTPP Due Diligence session) and Sydney during what is called "hedge fund super week" that includes the AIMA Australia Annual Forum and other industry events.

AIMA Canada's Legal & Finance Committee submitted four comment letters to securities regulatory authorities on topics of importance to the industry. We also organized a special working group consisting of a broad cross-section of managers (by size and strategy) and service providers to comment on draft amendments to National Instrument 81-102 – Mutual Funds and related instruments (the Alternative Funds Proposals) which, once implemented, would allow alternative investment funds and strategies to be offered to retail Canadian investors in the same manner as conventional mutual funds.

I would like to take this opportunity to sincerely thank all of the co-chairs and committee members of our nine Committees across Canada for volunteering their valuable time and for all of their hard work over this past year.

AIMA's bi-annual elections were completed in September of 2016. Our executive board is now at its largest number ever and is comprised of an experienced and diverse group of individuals including **Claude Perron** as Vice Chair (Crystalline Management), **Derek Hatoum** as Treasurer (PricewaterhouseCoopers LLP), **Darin Renton** as Legal Counsel (Stikeman Elliott LLP), **Claire Van Wyk** (RBC Global Asset Management), **Anish Chopra** (TD Asset Management), **Steve Banquier** (TD Securities), **Ranjan Bhaduri** (Sigma Analysis & Management), **Belle Kaura** (Third Eye Capital), **Jesse Kaufman** (Richardson GMP), **Laura Reid** (KPMG LLP) and **Stéphane Amara** (Allianz Global Investors) as well as James Burrton from AIMA Canada staff. We would like to thank departing executive board members *Paul Patterson* (Next Edge Capital) and *Tim Baron* (Davies, Ward, Phillips and Vineberg LLP) for their years of service to AIMA Canada.

In the coming year, we will be front and centre in working with regulators on the Alternative Funds Proposals which could have a transformational effect on our industry. We will continue our work promoting Canadian managers to investors both within Canada and globally. Nationally, we will be looking to increase our profile through public events and the media. At the international level, this will be accomplished both through promotional efforts within AIMA and through a continuation of Canadian Embassy/Consulate events (this year primarily within the United States) providing managers with the opportunity to network with foreign institutional investors.

I would like to thank you for your membership in AIMA and your commitment to our efforts, events and the Canadian alternative investment industry as a whole. If you ever have suggestions as to how we can improve our service offering to you, please feel free to contact me or any member of our executive board at any time.

I am very excited for the coming year and would like to take this opportunity to wish each of you and your families a Happy New Year! Together we can make 2017 the most meaningful and productive year for the Canadian alternative investment industry yet!

INDUSTRY REGULATORY AND ADVOCACY ACTIVITIES

AIMA Canada submitted a number of comment letters to the Canadian regulators on a variety of issues of interest to members and the industry at large.

Our various committees and working groups, and AIMA Canada and AIMA head office staff also had numerous meetings with various regulators across Canada on a variety of issues including the comment letter topics listed below.

AIMA Canada Comment Letter regarding the Canadian Securities Administrators (CSA) Mutual Fund Risk Classification Methodology for Use in Fund Facts and ETF Facts (March 2016)

AIMA Canada found many areas of this proposal lacking, although we did agree that a suitable fund fact sheet should be designed to assist investors in assessing the risk and return potential of mutual funds and ETFs.

Specifically: some strategies do not have a relevant reference index; seemingly applicable indices comprised of funds with similar strategies may be misleading; it may not be possible to find an index as per direction by the CSA; funds created under the Alternative Funds Proposal (see Dec 2016 comment letter) would have zero performance history; and a 10-year timeframe to assess risk is too long.

AIMA Canada Comment Letter regarding OSC Rule 72-503 Distributions Outside of Canada and CP 72-503CP (September 2016)

We opined that the proposal was positive, with a few modifications (such as annual filing vs within 10 days of trade date), a suggestion to have a more complete example of what is expected in terms of the filing process, and a question as to whether investors outside of Canada are, by law, entitled to rights and protections as an Ontario investor would be.

AIMA Canada Comment Letter regarding CSA Proposal 33-404 (September 2016)

This proposal set about a so-called 'best interest' or 'client first' regime which we support in principal, but the implementation of that notion under the proposed framework presented many practical impediments that would make its implementation difficult and potentially impossible.

AIMA Canada Comment Letter on Modernization of Investment Fund Product Regulation - Alternative Funds (December 2016)

After numerous consultations with members during the comment period and prior, AIMA Canada drafted its comment on this important proposal.

Comments focused on leverage, illiquid assets, and counterparty risk.

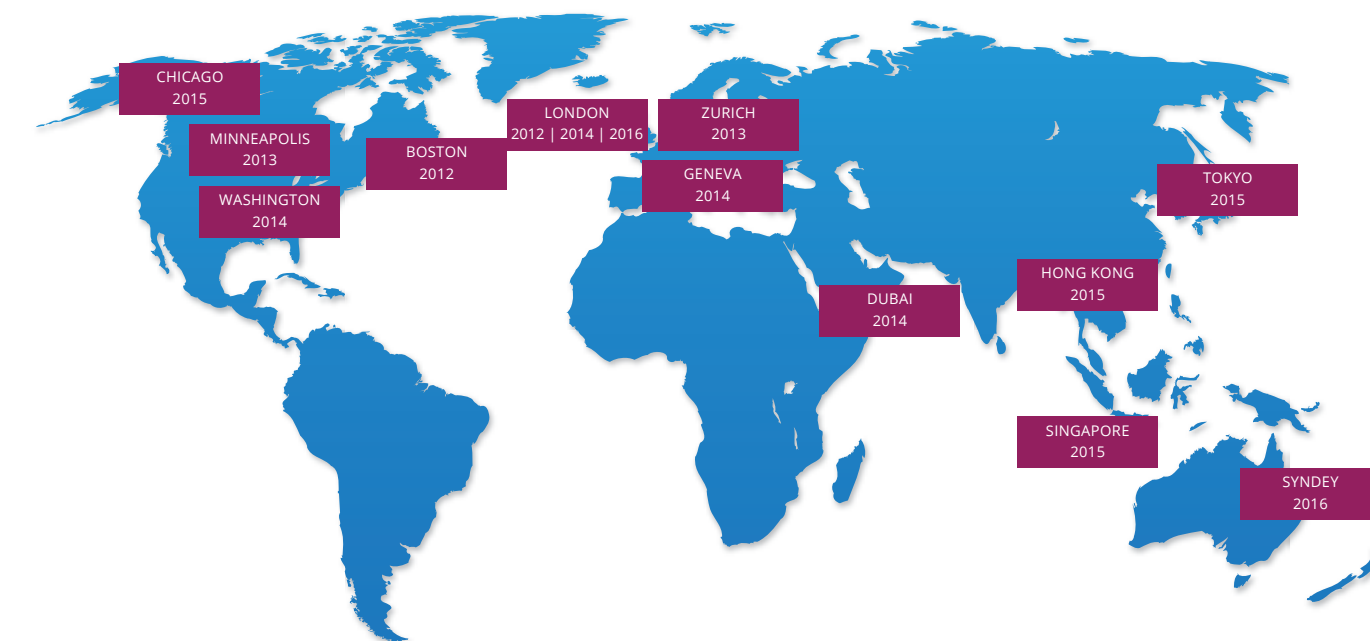

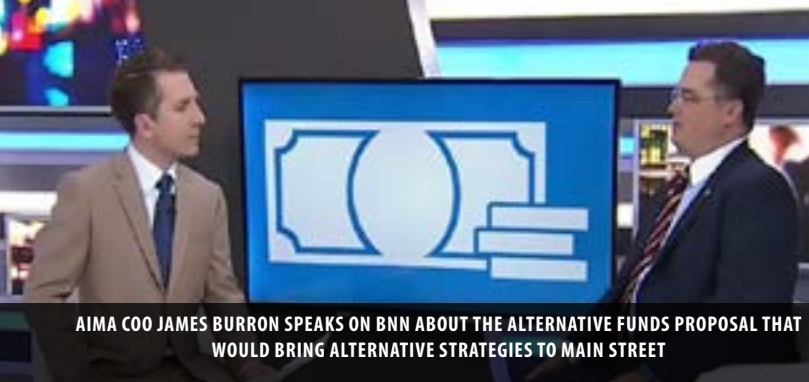

AIMA CANADA INVESTOR FORUM

OCTOBER 5-6, 2016
Westin Centre Montréal
Montréal, Québec

Our second annual Investor lived up to its goal with an excellent array of prestigious speakers and a 1:1:1 ratio among investor, manager and service provider attendees numbering approximately 180 in total.

Spanning 1.5 days, it began with an investor-only hedge fund investing workshop and 2 open streams covering sales & marketing and operations & compliance sessions.

The main day of the conference featured investor/allocator-only panels on trending topics such as due diligence, accessing hedge fund strategies, seeding and emerging managers, and perspectives on how to use hedge funds and hedge fund strategies in a portfolio setting.

The conference was under Chatham House Rule, where participants are free to use the information received, but neither the identity nor the affiliation of the speaker(s), nor that of any other participant, may be revealed. This allowed panelists to speak more freely and provided very insightful views for the audience.

Interspersed during the day were so-called speed-dating or match-making sessions where investors, managers, and service providers set aside time to meet and discuss offerings and requirements. These meetings were entirely opt-in for both sides and accommodated those who wished to have meetings as well as learn from the various panel discussions.

Each day had a reception speaker: day 1 featured three-time Olympian (2 gold medals) Alex Bilodeau and day 2 brought Samuel Effah to the stage (4th fastest Canadian alive).

Speakers and attendees, all of which were either AIMA members or real money investors (e.g., pension funds, sovereign wealth funds, foundations, endowments, or single family offices), came from across Canada, the United States, the United Kingdom, Europe, Asia, and the Middle East.

Attendees and participants of all types gave high marks for the panels and many aspects of the conference as well as welcomed advice on how to make our next iteration even better.
